PUBLIC HEARING

- (4) Wye Road Intersection Improvements Project – A public hearing will be held to hear and consider comment on the Initial Study and Negative Declaration on the proposed project to widen and realign the intersection of Wye Road and Highway 6 / North Main Street. The work will provide free right turn lanes, dedicated left turn lanes and through traffic lanes on Wye Road which align across the east and west sides of Highway 6. To allow the work the City of Bishop proposes to acquire right of way north of Wye Road and relocate overhead utilities.
