## Request For Bids

### Sign Panels

**Release:** 8 May 2014

**Closes:** 20 May 2014

**General:** The City of Bishop requests bids for the purchase of sign panels for city streets. Bids shall be delivered to Bishop Public Works at City Hall at 377 West Line Street, Bishop, California 93514, publicworks@ca-bishop.us. Bids shall be accepted until 3 pm on the close date of this request and shall be clearly identified "Sign Panels Bid".

**Purchasing Preferences:** City of Bishop contracting preferences apply to this purchase. The city provides a preference to small and local businesses in accordance with Section 3.26 of the Municipal Code.

#### Sign Panel Requirements:

1. The sign panels shall conform to the California Manual of Uniform Traffic Control Devices (MUTCD).
2. The sign panels shall be D3-1 as shown in the MUTCD and generally conform to the attached Example Sign For "West Line Street" sketch.
3. The sign panel text and the quantity of each panel shall be as shown on the attached list of sign panels.
4. The sign panels shall conform to Section 56, Signs, of the Caltrans Standard Specifications.
5. The sign panels shall use single aluminum sheeting.
6. The sign panels purchase shall include mounting hardware. Mounting hardware shall consist of 130 brackets for mounting panels at top of "u-channel" sign posts (equivalent to Zumar 808FUC180) and 130 brackets

for mounting panels on top of and at 90 degrees to other panels (equivalent to Zumar 808F90X), all including required screws.


**Bid Requirements:**

The bid shall reference and include all documentation necessary to demonstrate minimum requirements are met. The bid cost shall be the total cost of the sign panels, including all applicable taxes and fees, delivered to the City of Bishop Public Works Shop at 151 South Warren Street in Bishop. If small business contracting preference is claimed, bid shall be accompanied by the bidders California Small Business number. If local business contracting preference is claimed, bid shall be accompanied with the attached form, completed by the bidder.
