General: The City of Bishop requests bids for the purchase of sign panels, posts, and related hardware for city streets. Bids shall be delivered to Bishop Public Works at City Hall at 377 West Line Street, Bishop, California 93514, publicworks@ca-bishop.us. Bids shall be accepted until 3 pm on the close date of this request and shall be clearly identified "Sign Panels Bid 2015".

Purchasing Preferences: City of Bishop contracting preferences apply to this purchase. The city provides a preference to small and local businesses in accordance with Section 3.26 of the Municipal Code.

Sign Panel Requirements:

1. The sign panels shall conform to the California Manual of Uniform Traffic Control Devices (MUTCD).

2. The sign panels and the quantity of each panel shall be as shown on the attached list of sign panels.
3. The sign panels shall conform to Section 56, Signs, of the Caltrans Standard Specifications.

4. The sign panels shall use single aluminum sheeting.
5. The sign panels purchase shall include 50 steel "u-channel" posts 10 feet long equivalent to Rice Signs P2-GR.

6. The sign panels purchase shall include mounting hardware equivalent to the Galvanized Steel Sign Mounting Hardware available from Rice Signs for all panels.
7. The sign panels purchase shall include mounting hardware for mounting street name signs to "u-channel" posts. The mounting hardware for mounting street name signs shall include 10 sets of mounting hardware equivalent to Rice Signs H-1200-F and 10 sets of mounting hardware equivalent to Rice Signs H-1210-F.
8. Delivery is desired no later than 1 May 2015.

Bid Requirements:

1. The bid shall reference and include all documentation necessary to demonstrate minimum requirements are met.
2. The bid cost shall be the total cost of the sign panels, including all applicable taxes and fees, delivered to the City of Bishop Public Works Shop at 151 South Warren Street in Bishop.
3. If small business contracting preference is claimed, bid shall be accompanied by the bidders California Small Business number. If local business contracting preference is claimed, bid shall be accompanied with the attached form, completed by the bidder.
