
Location: N. Sierra Highway at Shell Y Mart, Bishop.

Suspect: **ASTLUND, CODY STEVEN. 26 year old Post Falls, ID resident.**

On January 25, 2015 at 11:18pm, the Bishop Police K9 Officer conducted a traffic enforcement stop on a vehicle. The Driver, Cody Astlund could not produce a Driver's License. Officers further developed legal cause to search the vehicle Astlund was driving. During the search, Officers discovered illegal drugs, plastic containers, stash cans, packaging materials, and drug paraphernalia. Also found inside the vehicle was a loaded handgun and several rounds of ammunition.

The total amount of illegal drugs recovered by law enforcement was 197.3 grams (approx. 7 ounces) of Methamphetamine.

ASTLUND, Cody Steven was arrested for 11377(a) HS- Possession of a controlled substance; 11379(A) HS Transportation of a controlled substance; 29800(a)(1) PC-Possession of a firearm by a felon; 11378 HS- Possession of controlled substance for sale; 25400(a)(1) PC-Concealed firearm within the vehicle; and 30305(a) PC-Possession of ammunition, prohibited. ASTLUND was transported to the Inyo County Jail and is currently awaiting arraignment.

Suspect: **BALDERASROBLEDO, MAXIMO ALAN. 25 year old Lone Pine, CA resident.**

On January 27, 2015 at 12:38am, the Bishop Police Department received a report of a suspicious male subject and vehicle in the area of Grove and Schley Street. In the past few weeks, this area has had several reports of thefts of property. The Reporting Party stated that a large male subject got out of the vehicle and continued to walk down Schley Street. Officers searched the area and located the vehicle described by the reporting party. Officers contacted a female inside the parked vehicle who claimed to have relatives in the area and that her “boyfriend” was trying to find where they lived. As Officer were speaking to the female, they noticed a male subject walking down West Elm Street. Officers attempted to contact the subject, but were unable to immediately locate him.

With the assistance of the Inyo County Sheriff’s Department, officers were able to locate the subject, identified as Balderasrobledo, Maximo Alan, when he returned to his vehicle on Schley Street. While conducting an investigation on Balderasrobledo, Officers discovered that Balderasrobledo was in possession of burglary tools and illegal drugs.

BALDERASROBLEDO, Maximo Alan was arrested for 466 PC-Possession of burglary tools; 11364 HS-Possession of a controlled substance; 22210 PC-Possession of an illegal weapon; and 1203.2/M PC-Violation of Probation. BALDERASROBLEDO was transported to the Inyo County Jail and is currently awaiting arraignment.
